

INSTRUCTIONS FOR COMPLETION OF STATEMENT

Type or carefully print in ink

Box A. Insert the name and address of the person who should receive this original and certified copy.

Box 1. Check one box only.

Box 2. Insert exact name of business. If you are registering more than one business located at the same address, number each name entered.

Box 3. Insert street address of principal place of business (Post Office Boxes are not acceptable).

Box 4. Registrants: list each owner or partner and his/her residence address separately (Post Office Boxes are not acceptable). If the owner is a corporation insert the name of the corporation and the business address. Do not list stockholders or officers of the corporation. If a business name or a registrant's name includes the words "Corporation", "Incorporated", or "Inc.", "Limited Liability Company" (whether using the complete words or abbreviations "LLC" and "Co." or either of them) or "LLC" or "LC", the County Clerk of Los Angeles requires a certified copy of the Articles of Incorporation or Organization.

Box 5. Check one item which best describes who is conducting business.

Box 6. Do not leave blank.

Box 7. Please read before signing.

Box 8. Signatures are required as follows () individual - the individual, () Partnership or other association of other persons - A general partner, () Joint Venture - All parties of the joint venture, () Business Trust - A trustee, () Co-Partners - All partners, () Husband and Wife.

Box 8A. Corporation/Limited Liability Co. - An officer must sign, state the title, and attach a copy of the endorsed (filed) Articles of Incorporation or Organization.

CALIFORNIA BUSINESS AND PROFESSIONS CODE

SECTION 14411, 14412 - TRADE NAME REGISTRATION

The filing of any fictitious business name statement by a person required to file such statement shall establish a rebuttable presumption that the registrant has the exclusive right to use the fictitious business name as a trade name as well as any confusingly similar trade name, in the county in which the statement is filed, if the registrant is the first to file such a statement containing the fictitious business name in the county. The rebuttable presumption shall be applicable until the statement is abandoned or otherwise expires and no new statement has been filed by the registrant.

SECTION 17900 -

(a)-as used in this chapter, 'fictitious business name' means:

(1) In the case of an individual, a name that does not include the surname of the individual or a name that suggests the existence of additional owners.

(2) In the case of a partnership or other association of persons, other than a limited partnership which has filed a certificate of limited partnership with the Secretary of State pursuant to Section 15621 of the Corporations Code, a name that does not include the surname of each general partner or a name that suggests the existence of additional owners.

(3) In the case of a corporation, any name other than the corporate name stated in its articles of incorporation.

(4) In the case of a limited partnership which has filed a certificate of limited partnership with the Secretary of State pursuant to Section 15621 of the Corporations Code and in the case of a foreign limited partnership which has filed an application for registration with the Secretary of State pursuant to Section 15621 of the Corporations Code, any name other than the name of the limited partnership as on file with the Secretary of State.

(b) A name that suggests the existence of additional owners within the meaning of subdivision (a) is one which includes such words as 'Company', '& Company', 'Son,' & Associates,' 'Brothers,' and the like, but not words that merely describe the business being conducted.

SECTION 17910 - Every person who regularly transacts business in this state for profit under a fictitious business name shall:

(a) File a fictitious business name statement in accordance with this chapter not later than 40 days from the time he commences to transact such business; and

(b) File a new statement in accordance with this chapter on or before the date of expiration of the statement on file.

SECTION 17910.5 -

(a) No person shall adopt any fictitious business name which includes 'Corporation,' 'Incorporated,' or 'Inc,' unless such person is a corporation organized pursuant to the laws of this state or some other jurisdiction.

(b) No person shall adopt any Fictitious Business Name which includes "Limited Liability Company" (whether using the complete words or the abbreviations "LTD and Co." or either of them) or "LLC" or "LC" unless such a person is a Limited Company organized pursuant to the laws of this state or some other jurisdiction.

SECTION 17917-

(a) Within 30 days after a fictitious business name statement has been filed pursuant to this chapter, the registrant shall cause a statement in the form prescribed by subdivision (a) of Section 17913 to be published pursuant to Government Code Section 6064 (once per week for four successive weeks) in a newspaper of general circulation in the County in which the principal place of business of the registrant is located or, if there is no such newspaper in that county, then in a newspaper of general circulation in an adjoining county. If the registrant does not have a place of business in this state, the notice shall be published in a newspaper of general circulation in Sacramento County.

(b) Subject to the requirements of subdivision (a), the newspaper selected for the publication of the statement should be one that circulates in the area where the business is to be conducted.

(c) If a refiling is required because the prior statement has expired, the refiling need not be published unless there has been a change in the information required in the expired statement, **provided the refiling is filed within 40 days of the date the statement expires.**

(d) An affidavit showing the publication of the statement shall be filed with the county clerk within 30 days after the completion of the publication.

SECTION 17920. Expiration of statement

(a) Unless the statement expires earlier under subdivision (b) or (c), **a fictitious business name statement expires five years from the date it was filed in the office of the county clerk.**

(b) Except as provided in Section 17923, **a fictitious business name statement expires 40 days after any change in the facts set forth in the statement** pursuant to Section 17913, except that a change in the residence address of an individual, general partner or trustee does not cause the statement to expire.

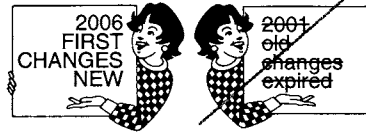
(c) A fictitious business name statement expires when registrant files a statement of abandonment of the fictitious business name described in the statement.

SECTION 17930 - Any person who executes, files, or publishes any statement under this chapter, knowing that such statement is false, in whole or in part, shall be guilty of a misdemeanor and upon conviction thereof shall be punished by a fine not to exceed one thousand dollars (\$1,000).

* **NOTE:** It is your responsibility not to file the same name or one confusingly similar to one already registered on the County FBN Index or Secretary of State Corporate Index. We suggest you search available records before filing.

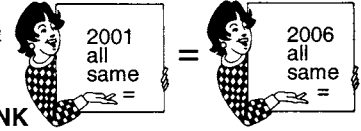
- 1 - **Print clearly** in black ink 2, 3, 4, 5, 6 (OLD Changes we retype)
- 2 - **Sign 8 in BLACK INK** and print your name
 or **officer Sign 8A only in BLACK INK** if Corporation/ LLC.
- 3 - **Pay** two checks - \$87 Legal Desk AAD News & \$23 LA County Clerk - Add to LA Clerk check \$4 per extra business name in 2-2, 2-3 etc. and extra registrant 4B, 4C, etc.
- 4 - **Mail SIGNED ORIGINAL FORM** (*with filed Articles if Corp or LLC) and **two checks.**

*-Corporations or LLC mail with filed Articles of Incorporation/Org copy.

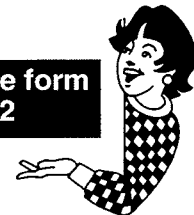

By California State law you must file and publish your Fictitious Business Name Statement within 40 days after you begin your business. It is good for 5 years. If you change any of the business facts on the statement (like change of address) your statement automatically expires and you must file and publish within 40 days.

First Filing with new information / NEW file / CHANGES on any line / EXPIRED file.

By California State law you must file and publish your Fictitious Business Name Statement within 40 days after you begin your business. It is good for 5 years. If you change any of the business facts on the statement (like change of address) your statement automatically expires and you must file and publish within 40 days.

Renewal Filing - NO CHANGES on any line since 5 years ago.

By state law it's time to renew your Fictitious Business Name Statement for 5 more years in LA County!

Common mistakes on Renewal Filings:

- Corporations or Limited Liability Companies (LLC) forget to send a copy of filed Articles of Incorporation or Organization with the signed form and two checks. LA County Clerk requests a copy of the articles to verify that a corporation or LLC is registered.
- Add \$4. to the LA Clerk check for each extra business name printed in 2-2, 2-3 etc. and add \$4 to the LA Clerk check for each extra registrant after 4A printed in 4B, 4C etc. (husband and wife pay \$18. three partners pay \$22.; four partners pay \$28. etc.)
- People aren't sure who should sign the Renewal Filing form. How you mark line 5 tells you who must sign your form. Think of "who owns the business"; it may help you choose the correct line to mark below:

- () husband and wife -print both names & addresses in 4 & 4A -**both husband and wife must sign 8**
- () an unincorporated association other than a partnership -print names & home addresses of ALL associates in 4, 4A, 4B etc. -**one associate must sign 8**
- () general partnership -print names & home addresses of ALL partners in 4, 4A, 4B etc. -**one partner sign 8**
- () limited partnership -print limited partner's name and address in 4 -**one limited partner must sign 8**
- () co-partners - print names and home addresses of ALL partners in 4, 4A, 4B etc. -**all co-partners must sign 8**
- () a corporation - in 4 print corporation name & address -**one officer must sign 8A only & mail a filed copy of the articles of incorporation with signed form and two checks**
- () a limited liability company (LLC) -in 4 print LLC name & address -**one officer must sign 8A only & mail a copy of the articles of organization with signed form and two checks**
- () joint venture - print ALL names & addresses in 4, 4A, 4B etc. -**all must sign 8**
- () business trust - print name of trust, date of trust, trustee's name & address in 4 -**one trustee must sign 8**

*Add to LA CLERK check- \$4 per extra business name 2-2, 2-3 etc. and \$4 per extra registrant 4B, 4C etc. See front side of this form 2-2 and 4B

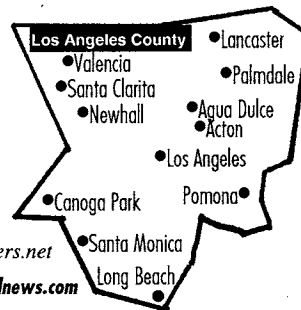
COMPLETE form - SIGN form - MAIL BACK original form with 2 CHECKS in envelope.

Check to make sure all information is correct. DON'T FORGET TO SIGN 8 or 8A (only corporations/LLC). Enclose two checks: one check payable to LA County Clerk for **\$18. and another check payable to Legal Desk AAD News for \$63. if there are NO CHANGES from your previous filing ---- or one check payable to LA County Clerk for *\$23 and \$87 to Legal Desk AAD News if there are ANY CHANGES since your filing five years ago or you make a new filing. When your signed form and two checks arrive at the newspaper, the legal staff will personally hand-file your documents with Los Angeles County; on the next working day our legal staff will send one conformed and numbered, county-stamped copy back to you for you and/or your bank. Then the legal staff will publish your fictitious business name statement in the newspaper for 4 successive weeks (applies to all changed filings or new filings) and will file a signed affidavit of publication with Los Angeles County; Los Angeles County will microfilm/digitize your original document(s) and mail it/them back to you (applies to all filings) and mail our original affidavit of publication back to you after it has been recorded on microfilm/digitized (applies to all changed filings and new filings).
