DON'T FORGET! YOUR BUSINESS NAME FILING IS ONLY GOOD FOR 5 YEARS IN LA COUNTY!

- By state law you must renew your business name every five years. If you do not renew your name on time, it will stop (expire). Someone may take your business name if you do not renew it on time.
- If you change business address or change owners, you must file a new FBN within 40 days.

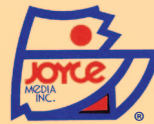
